Guaranteed Attendance

If no changes are made, the expected attendance will be used as the guarantee. We request 2 business days notice for any changes to final orders. Please note a \$25 administrative fee will apply.

Bartender Fee

A \$100 bartender fee will be applied to events with bars unless their bar sales meet or exceed \$350, at which point this charge will be removed.
